Introduction

This HySelect project privacy notice informs the data subjects in compliance with the EU General Data Protection Regulation (hereinafter referred to as the "GDPR") Art 13 ("Information provided to the data subjects to be provided where personal data are collected from the data subject") in regard to dissemination through media in the HySelect project.

This document expresses the common understanding of the data use by the project partners and constitutes the transparent arrangement that shall determine their respective responsibilities for compliance with the obligations under GDPR, in particular as regards the exercising of the rights of the data subject.

Processing of personal data

During events such as meetings, workshops, conferences or webinars that will take place in the course of the project, video and photographic material can be recorded by FEN Research as well as any of the involved partners in the project. In order to comply with Art. 13 of the "GDPR" the following information in regard to the project is provided:

Identity and the contact details of the controller Art.13 sub 1.(a) GDPR

In accordance with the Grant Agreement and the dissemination strategy for the project HySelect (currently under preparation), notably work package WP9 Knowledge and innovation management, dissemination and communication, the

is responsible for the dissemination and exploitation management and therefore also acting as the main and sole data controller and the designated contact point for the data subjects whose personal data is processed in the project.

Purpose of the data processing Art. 13 sub 1.(c) GDPR

The processing and publication of the material is carried out in the legitimate interest of the project partners for the purpose of an illustrated coverage of the event or to present the activities of the project to the public. Non-confidential photographic and video material recorded during project related workshops and other events will be published on the project website and project related websites and shared on social media within and beyond the project







duration. This material will also be available to project partners for dissemination on their websites.

Legal basis of the data processing Art.6 sub 1.(f) and sub 1.(d) GDPR

All data processing is based on the legitimate interests (the reporting of events, workshops, etc.) pursued by the responsible partner or a third party. In case of an objection by a data subject, an e-mail is to be sent to GDPR@fen-research.org. Contact can also be established by any other means using the contact information of the controller provided above. The production and use of the photographs and video recordings shall be pointed out by information provided to the data subjects when informing of the events or with leaflets given to data subjects as in the dissemination, communication and awareness plan. Care must be taken both in the production of photographs and video recordings and their publication, in order to not violate any rights of depicted persons. In the case that the rights of a certain person(s) are violated, for reasons worthy of special consideration, the project partners will refrain from further processing by taking appropriate measures. Removal of the information on the websites or in social media channels takes place within the scope of technical possibilities.

Storage period Art. 13 sub 2.(a) GDPR

The photographs and video recordings are stored for the project duration and afterwards archived by FEN Research for as long as a legitimate interest to verify and inform of project activities exists. Information of the project published in different publications, websites and social media sites will be public documents available as part of freedom of expression. Data subjects may exercise their right to request removal of their personal data.

Recipient categories Art.13 sub 1.(e), sub 1.(f) and sub 2.(f) GDPR

The photo and video recordings are made available to the public on the internet and published in social media channels. There is no automated decision making (profiling).

Rights of the data subject and right of complaint to the supervisory authority

All data subjects have the right to request correction, removal, restriction, or right to object to data processing within the framework of the legal provisions of GDPR. To exercise those rights, contact should be made with FEN Research by email to <u>GDPR@fen-research.org</u> or by any means using the contact information of the main controller given above.
